The name of the issuer is CAI International, Inc. (the "Company").

The shares of common stock of the Issuer which are the subject of this Schedule 13G/A #1 (the "Shares") are held by the Master Fund. Beneficial ownership of the Shares is also claimed by (i) Mangrove Partners which serves as the investment manager of the Master Fund, and (iii) Nathaniel August who is the controlling person of Mangrove Partners.
